

WinGIS Professional Services Agreement

The Winnebago County Geographic Information System (hereinafter referred to as WinGIS), hereby grants to _____ Name of Licensee (hereinafter referred to as Licensee), a license to use, in accordance with this agreement, the WinGIS professional services as described in Schedule A* to this agreement. Licensee agrees to pay the fees as defined in Schedule A*.

NO WARRANTY: WinGIS provides these professional services and associated geographic data in digital or print form "as is". WinGIS makes no guarantee or warranty concerning the accuracy of information contained in the geographic data or professional services rendered. WinGIS further makes no warranties, either expressed or implied, as to any other matter whatsoever, including, without limitation, the condition of the product, or its fitness for any particular purpose. The burden for determining fitness for use lies entirely with the user. Although these data, computer programs, GIS scripts, or applications have been processed successfully on computers of WinGIS, nor warranty, expressed or implied, is made by WinGIS regarding the use of these data, programs, scripts, or applications on any other system, nor does the fact of distribution constitute or imply any such warranty. WinGIS provides no continuing support for previous services rendered.
